YOUR EXCELLENCY:

I READ THE ENCLOSED ARTICLE IN MY HOMETOWN NEWSPAPER (JULY 20, 1979) WITH A GREAT DEAL OF INTEREST, AND I WANT TO CONGRATULATE YOU ON THE POSITION AS PRIME MINISTER. IN A SENSE, YOUR JOURNEY AND MINE PARALLEL. MY THOUGHTS AND PRAYERS WILL BE WITH YOU AS YOU LEAD YOUR COUNTRY ON A PROGRESSIVE PATH.

I HAVE ALSO BEEN ON A PROGRESSIVE PATH: FIRST AS A WOMAN IN BUSINESS IN A MAN'S WORLD; SECONDLY, IN DEVELOPING MY BUSINESS FROM DOMESTIC TO INTERNATIONAL PUBLIC RELATIONS. 
