Continuing its consideration of item 89, the Committee heard statements by the representatives of Sierra Leone, Hungary, Egypt, China, Mexico, Australia, Chad, the United States and Turkey.

Measures to prevent international terrorism which endangers or takes innocent human lives or jeopardizes fundamental freedoms, and study of the underlying causes of those forms of terrorism and acts of violence which lie in misery, frustration, grievance and despair and which cause some people to sacrifice human lives, including their own, in an attempt to effect radical changes [92]

The Chairman drew the Committee's attention to the revised draft resolution (A/C.1/L.631/Rev.1) on the item, together with the Secretary-General's statement on the administrative and financial implications thereof, contained in document A/C.1/L.633.

Following a statement by the representative of Sri Lanka, the Committee decided to vote on the revised draft resolution as it stood, on the understanding that the Chairman would continue his consultations on the membership of the ad hoc committee, mentioned in operative paragraph 3 thereof, and would submit the names of those nominated to serve on that committee before the item came to the vote in plenary.

The representative of Liberia spoke on a point of order.

The representative of South Africa made a statement.

Statements in explanation of vote were then made by the representatives of Thailand, China, Japan, the United States, Canada, the Philippines, Brazil and the United Kingdom.

Declaration of the Indian ocean as a zone of peace: report of the Secretary-General [34]

The Chairman informed the Committee that Madagascar and Somalia had become co-sponsors of the revised draft resolution.

Statements in explanation of vote were made by the representatives of the USSR and Peru.

The Committee adopted revised draft resolution A/C.1/L.631/ Rev.1 by a roll-call vote of 72 to none, with 35 abstentions.

Statements in explanation of vote were made by the representatives of Italy, France, Sweden and Democratic Yemen.

The representatives of Somalia and Sri Lanka made statements.

The representative of India made a statement in exercise of the right of reply.

The Committee thus concluded its consideration of item 34.

Report of the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Population of the Occupied Territories [42]

The Committee continued its general debate on item 42 with statements by the representatives of the Syrian Arab Republic, the Sudan, Malaysia, Hungary, Mali, Poland and France.

The Chairman announced that Afghanistan, Indonesia and Malaysia had become co-sponsors of the draft resolution circulated in document A/SPC/L.258.

The policies of apartheid of the Government of South Africa [38]

The representative of India, Rapporteur of the Special Committee on Apartheid, made a statement and introduced the draft resolution contained in document A/SPC/L.257, of which he stated Hungary should be regarded as an original co-sponsor. It was further announced that Algeria, Cameroon, Congo, Cuba, Ethiopia, Ghana, Indonesia, Jamaica, Kenya, Mali, Mauritania, Romania, Togo, Uganda, the United Republic of Tanzania and Zambia had joined as co-sponsors of the draft resolution.

The representative of the Syrian Arab Republic made a statement on the question.

SECOND COMMITTEE

Report of the Economic and Social Council [12]

Explanations of vote after the vote on draft resolution A/C.2/L.1271/Rev.1, which was adopted at the 1508th meeting, were made by the representatives of the USSR, Jordan, Ghana, France, Guatemala, Cuba, Greece and Belgium.

The representative of the Philippines introduced draft resolution A/C.2/L.1283, also on behalf of Indonesia, Malaysia, the Netherlands, Norway, Sweden, Uganda and the United States.

Draft resolution A/C.2/L.1276/Rev.1

Statements were made by the representatives of the Philippines (who orally revised the revised draft resolution in A/C.2/L.1276/Rev.1), Uruguay, China, Liberia, France, India, Brazil, the United States, the United Kingdom, Greece, the Sudan, Finland, the Upper Volta, Indonesia, Ethiopia, Australia, Uganda, Senegal, Argentina, Pakistan, Afghanistan and Zaire.

It was agreed to postpone the voting on the revised draft resolution in order to allow time for consultations,

It was announced that Sri Lanka should be added to the list of sponsors of A/C.2/L.1276/Rev.1 and that Japan should be added to the list of sponsors of A/C.2/L.1283.

Draft resolution A/C.2/L.1253*

Statements were made by the representatives of Honduras (who orally revised the oral proposal made at a previous meeting), Brazil, China, the United States, the Upper Volta, Japan, India, Afghanistan, Peru, Sweden, Greece and Egypt.

The proposal was adopted without objection.

Statements were made by the representatives of the USSR, Iraq and the United Kingdom.

United Nations Conference on Trade and Development [43]

Draft resolution A/C.2/L.1269

Statements were made by the representatives of Sri Lanka and Iraq.

The Committee adopted the draft resolution without a vote.

Draft resolution A/C.2/L.1270

Statements were made by the representatives of France (who orally revised the draft resolution), India, Japan, New Zealand, Denmark, Finland, Ghana, Mali, Nigeria, Zambia, the USSR, Bulgaria, Jordan, the Niger, Yugoslavia, Jamaica, the United Kingdom and France (who accepted, on behalf of the sponsors, the oral amendments proposed during the course of the discussion).

The Committee adopted the draft resolution, as orally revised, without a vote,

The representatives of the USSR and Cuba made statements.

Draft resolution A/C.2/L.1260/Rev.1

Statements were made by the representatives of the Upper Volta (who orally revised the revised draft resolution), India, Brazil, Denmark, Mexico, Japan, Finland, Italy, Argentina, the United Kingdom, Austria, Zambia, the United States, Ecuador, China, the Ukrainian SSR (who proposed an oral amendment), Colombia, France, Senegal, Sweden, Uganda and the Upper Volta (who accepted, on behalf of the sponsors, the oral amendment proposed by the Ukrainian SSR).

The Committee adopted the revised draft resolution, as orally revised, without objection.

Draft resolution A/C.2/L.1267/Rev.1

Statements were made by the representatives of Uruguay (who orally revised the revised draft resolution), Mexico, Canada, the United Kingdom (who proposed oral amendments), France, Yugoslavia, Japan, Australia, the United States, Greece, Pakistan, India, Spain, Kuwait and Honduras.

During the course of the discussion, a number of suggestions were put forward for the consideration of the sponsors of the revised draft resolution.

The representative of Argentina, on behalf of the sponsors, accepted some of the oral proposals put forward by the representatives of Australia, Japan and Mexico.

On a recorded vote requested by Uruguay, the Committee then proceeded to vote on the revised draft resolution and the amendments thereto as follows:

By 65 votes to 18, with 20 abstentions, the Committee rejected the oral amendments proposed by the United Kingdom.

On a separate vote requested by the Netherlands, on the words "including... on that debt;", in operative paragraph 1 as revised, the Committee decided by 77 votes to 13, with 12 abstentions, to retain those words.

By 84 votes to 1, with 17 abstentions, the Committee adopted the revised draft resolution as a whole, as orally revised.

Principles of international co-operation in the detection, arrest, extradition and punishment of persons guilty of war crimes and crimes against humanity [52]

The Committee concluded consideration of item 52 and of a draft resolution relating to the draft principles submitted by Bulgaria and Cuba (A/C.3/L.1986) subsequently sponsored also by Colombia and Cuinea

The representatives of the Libyan Arab Republic, Saudi Arabia, Colombia, Lebanon, Iraq, Bulgaria, Ecuador, the Dominican Republic and Morocco made statements.

The representatives of Pakistan and Portugal made statements in explanation of vote before the voting.

The draft resolution was adopted by 81 votes to none, with 18 abstentions.

Statements in explanation of vote were made by the representatives of Costa Rica, the United States, the United Kingdom, Ecuador, Turkey, Honduras, Greece, Argentina, Iran and Denmark.

Elimination of all forms of religious intolerance [59]

The Committee concluded consideration of the item, of the draft resolution submitted on it (A/C.3/L.1980) subsequently sponsored also by Cyprus, Honduras and Iceland, and of the amendments thereto submitted by the USSR and contained in A/C.3/L.1985.

The representatives of Uruguay, the Netherlands, the USSR, the Byelorussian SSR, Turkey, Cyprus, Sweden, India, Morocco, Liberia, Brazil, Madagascar, Cuba and Mali made statements.

The representative of India made a statement in explanation of a vote before the voting.

At the request of the representative of the Netherlands, a roll-call vote was taken on the second amendment of the USSR.

At the request of the representative of Turkey, a separate vote was taken on the words "of the advisability" in the same paragraph.

The Director of the Division of Human Rights made a statement in reply to a question raised by the representative of India.

The voting on the amendments contained in document A/C.3/L.1985 was as follows:

On 4 December 1972, the instrument of ratification of the amendment to Article 61 of the Charter of the United Nations, adopted by General Assembly resolution 2847 (XXVI) of 20 December 1971, was received from the Government of Liberia.

On 5 December 1972, the instrument of ratification of the Vienna Convention on the Law of Treaties, done at Vienna on 23 May 1969, was received from the Government of Argentina.

On 5 December 1972, the instruments of ratification of the Convention on Psychotropic Substances, opened for signature at Vienna on 21 February 1971, and the Protocol amending the Single Convention on Narcotic Drugs, 1961, done at Geneva on 25 March 1972, were received from the Government of Sweden.

On 5 December 1972, the instrument of ratification of the Convention for the Protection of Producers of Phonograms against Unauthorized Duplication of their Phonograms, done at Geneva on 29 October 1971, was received from the Government of the United Kingdom of Great Britain and Northern Ireland.
