2095th plenary meeting

The situation in the Middle East [21]

Continuing its consideration of the item, the Assembly heard statements by the representatives of Turkey, the United Kingdom, Morocco and Bulgaria.

FIRST COMMITTEE

1907th meeting

Declaration of the Indian Ocean as a zone of peace; report of the Secretary-General [34]

The Committee decided to close the list of speakers at 6.00 p.m.

Reservation exclusively for peaceful purposes of the sea-bed and the ocean floor, and the subsoil thereof, underlying the high seas beyond the limits of present national jurisdiction and use of their resources in the interests of mankind, and convening of a conference on the law of the sea: report of the Committee on the Peaceful Uses of the Sea-Bed and the Ocean Floor beyond the Limits of National Jurisdiction [36]

The Chairman informed the Committee that the Niger had become a co-sponsor of draft resolution A/C.1/L.632.

The Committee continued its general debate with a statement by the representative of Japan.

1908th meeting

The general debate on item 36 continued with statements by the representatives of France, Austria, Sweden and Kuwait.

The Chairman informed the Committee that Burundi had become a co-sponsor of draft resolution A/C.1/L.632.

The representative of Thailand, on behalf of the sponsors, introduced draft resolution A/C.1/L.634. The representative of the United States made a statement.

SPECIAL POLITICAL COMMITTEE

850th meeting

Report of the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Population of the Occupied Territories [42]

The Committee agreed, at the suggestion of the Chairman, to close the list of speakers in the general debate on item 42 at the end of its meeting on Monday afternoon, 4 December. The representatives of Lebanon and the United Kingdom made statements in the general debate.

In accordance with the decision taken at its 849th meeting on 30 November, the Committee heard a statement on the question by Mr. Issa Nakhleh.

SECOND COMMITTEE

Operational activities for development [46]

Draft resolution A/C.2/L.1256

The Committee heard statements made in explanation of vote before the vote by the representatives of Finland, Austria, Mexico, the United Kingdom, Australia, Brazil, Sweden, Spain, Hungary, India, Turkey, Poland, Greece, Belgium, Tunisia, New Zealand, Pri it tan (who orally enied the operative paragraph of the draft resolution) and Denmark.

On a separate vote requested by the representative of New Zealand, the Committee, by 83 votes to 6, with 23 abstentions, decided to maintain the phrase "by at least 15 per cent annually" in the operative paragraph of the draft resolution. It then adopted the draft resolution (A/C.2/I.1256) as a whole, as amended, by 92 votes to 1, with 20 abstentions.

Statements in explanation of vote after the vote were made by the representatives of Iran, Japan, the USSR, New Zealand, France, Czechoslovakia, Bulgaria, Honduras, Italy, Greece and Liberia.

Revised draft resolution A/C.2/L.1263/Rev.1 and Corr.1

Statements were made by the representatives of the United States (who proposed an oral amendment to operative paragraph 1 of the revised draft resolution), India, the Netherlands (who orally proposed the insertion of the words "through ECOSOC" in operative paragraph 4), Argentina (who accepted the amendment proposed by the Netherlands) and Greece.

The Committee then, by 66 votes to 19, with 26 abstentions, rejected the oral amendment proposed by the United States, and by 104 votes to none, with 11 abstentions, adopted the revised draft resolution (A/C.2/L.1263/Rev.1 and Corr.1) as a whole, as amended.

A statement in explanation of vote after the vote was made by the representative of Brazil.

Draft resolution A/C, 2/L. 1264

The Committee adopted, without a vote, the draft resolution contained in document A/C.2/L.1264.

On a proposal by the Chairman, the Committee, without objection, took note with appreciation of the reports of the Governing Council of the United Nations Development Programme

on its thirteenth and fourteenth sessions (E/5092 and E/5185/Rev.1).

Report of the Economic and Social Council [12]

The Committee continued its consideration of the item.

The representative of the Philippines introduced draft resolution A/C.2/L.1276/Rev.1, also on behalf of Australia, Bolivia, Colombia, Iran and Morocco.

The Committee then took up draft resolution A/C.2/L.1253 and heard statements by the representatives of Hungary, Honduras, Poland, the Netherlands, Czechoslovakia, Pakistan, Brazil, the Ukrainian SSR, Mexico, Canada, Greece, Indonesia, Jordan, China, Finland, the United Kingdom, France, Norway, Egypt, the Sudan, Bulgaria, Italy, Kuwait, the United States, Sweden and the Syrian Arab Republic.

The Committee decided to delay further consideration of the draft resolution to allow for consultations.

The Committee then approved the draft section of its draft report (A/C.2/L.1258) on the question of the organization of the Committee's work at future session, as orally revised.

THIRD COMMITTEE

1967th meeting

Principles of international co-operation in the detection, arrest, extradition and punishment of persons guilty of war crimes and crimes against hmanity [52]

The Committee continued the consideration of the draft principles (A/C.3/L.1975). The representatives of India, Hungary, Austria, Egypt, France, the Ukrainian SSR, Cyprus and Chad made statements.

The representatives of Israel and Egypt made statements in exercise of the right of reply.

Elimination of all forms of religious intolerance [59]

The Committee continued the consideration of the dreft resolution (A/C.3/L.1980) sponsored also ty (ypnis and Hon uras. The representatives of the Netherlands, the USSK, Honduras, Morocco, Saudi Arabia, Sweden and the Byelorussian SSR made statements.

In view of the suggestions brought forward by the representative of the Byelorussian SSR, the sponsors revised the text of the second preambular paragraph.

The Committee decided to postpone the voting on the draft resolution until its next meeting when the sponsors will have had time to consider several suggestions brought forward by some delegations

The Chairman, with the consent of the Committee set 5.00 p.m., the same day, as the time-limit for the deposition of amendments to the draft resolution.

The Committee also heard statements by the representatives of Senegal and Chile.

FOURTH COMMITTEE

Draft resolution

The representative of Brazil spoke on a point of order.

The representative of the USSR spoke in exercise of the right of reply.

Budget estimates for the financial year 1973 [73]

Administrative and financial implications of the proposal adopted by the Second Committee concerning the United Nations Industrial Development Organization

Statements were made by the Chairman of the Advisory Committee on Administrative and Budgetary Questions and by the representative of the Upper Volta.

The Committee then decided, without objection, to inform the General Assembly directly that, should it approve the draft resolution recommended by the Second Committee, contained in document A/C.2/L.1238, an additional appropriation of \$30,000 would be required under Section 16 of the budget for 1973, and that the estimates for the biennium 1974/1975 would be considered by the Committee in the context of the Secretary-General's initial estimates for UNIDO for that biennium and in the light inter alia of the comments of the Advisory Committee in paragraph 5 of document A/8708/Add.12.

Administrative and budgetary co-ordination of the United Nations with the specialized agencies and the International Atomic Energy Agency [78]

Report of the Economic and Social Council [12]

Statements were made by the representatives of the Philippines, Belgium and Spain. After a brief procedural discussion in which the representatives of the Netherlands, Pakistan and the Philippines took part, the Committee decided to resume consideration of this item at a later date.
