Amsterdam Declaration on the Social Quality of Europe

Amsterdam, 14th April, 1997

Dear José Maria Gil-Robles.

On behalf of the new European Foundation on Social Quality it is a pleasure to invite you, as Chairman of the European Parliament, to formally accept the 'Declaration of Amsterdam on the Social Quality of Europe' during an official meeting in Amsterdam on Tuesday afternoon, June 19th, 1997. This Declaration will be prepared by fifty European social scientists (jurists, economists, sociologists and political scientists). Its purpose is to prepare the way - a.o. with support of the European Parliament - for new social policies regarding the European social quality.

The Declaration will be a result of the forthcoming book "Towards a Social Quality of Europe", to be published by Kluwer Law International (London, The Hague, Boston), a synopsis of which will be sent to you by fax. From Sunday evening June 8th, till Tuesday afternoon June 10th, fifty social scientists and fifty high level civil servants from the member states will discuss this book during the Invitation Conference. This Conference will be organized under responsibility of the Dutch Ministry of Health, Welfare and Sport and the European Commission.

After this Invitation Conference the social scientists will present their Declaration on Social Quality, assisted by representatives from the City of Amsterdam, the University of Amsterdam and the Amsterdam Free University. In principle, the European Foundation will be responsible for the diffisuion of this official presentation to the citizens of European European unification and the European institutions. With this in mind it will be a great honour if you as Chairman of the European Parliament are willing to take delivery of the Amsterdam Declaration to be presented by the chair of the European Foundation, prof. dr. Alan Walker.
