Thursday, 30 November 1972

GENERAL ASSEMBLY

2094th plenary meeting

The situation in the Middle East [21]

The Assembly continued its consideration of the item with statements by the representatives of Yugoslavia and Jordan.

On the proposal of the President, the Assembly decided that the list of speakers wishing to participate in the debate on the item would be closed on Friday, 1 December, at 6.00 p.m.

The representatives of Israel and Jordan made statements in exercise of the right of reply.

Committees

FIRST COMMITTEE

1906th meeting

Reservation exclusively for peaceful purposes of the sea-bed and the ocean floor, and the subsoil thereof, underlying the high seas beyond the limits of present national jurisdiction and use of their resources in the interests of mankind, and convening of a conference on the law of the sea: report of the Committee on the Peaceful Uses of the Sea-Bed and the Ocean Floor beyond the Limits of National Jurisdiction [36]

The general debate continued with statements by the representatives of Czechoslovakia, Indonesia, Canada, Liberia and Chile. The Chairman informed the Committee that the Upper Volta had become a co-sponsor of draft resolution A/C.1/L.632.

Programme of work

Following statements by the Chairman and by the representatives of Thailand, Sri Lanka, Canada and Malta, the Committee decided on its programme of work for the remainder of the session.

SPECIAL POLITICAL COMMITTEE

848th meeting

Comprehensive review of the whole question of peace-keeping operations in all their aspects: report of the Special Committee on Peace-keeping Operations [41]

The Committee proceeded with the discussion of the four-Power draft resolution (A/SPC/L.256), hearing statements by the representatives of Brazil, Sierra Leone, Argentina, France, Canada, Mali and Algeria.

In the course of his statement the representative of Mali proposed oral amendments to operative paragraphs 2, 3 and 6 of the draft resolution. The representatives of France and Algeria proposed oral sub-amendments to the amendments proposed by Mali, and these were accepted by the sponsors of the draft resolution.

The Committee then adopted the draft resolution (A/SPC/L.256), as amended, without objection.

The Committee thus concluded its consideration of item 41 of the agenda.

849th meeting

Report of the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Population of the Occupied Territories [42]

The representative of Sri Lanka, Chairman of the Special Committee to Investigate Israeli Practices Affecting the Human Rights of the Population of the Occupied Territories, made a statement and presented the Special Committee's report (A/8828).

The Committee began its general debate on the item with statements by the representatives of Israel and Egypt.

The Committee decided that, acting in conformity with the practice followed at previous session, it would grant hearings during its consideration of the item as requested in a letter dated 27 October 1972 (A/SPC/158) from the representatives of Afghanistan, Indonesia, Pakistan and Saudi Arabia. The representative of Israel made a statement in that connexion.

The representatives of Jordan, Sri Lanka and Kuwait spoke in exercise of the right of reply.

SECOND COMMITTEE

1504th meeting

Question of the establishment of an international university [48]

The Committee continued its consideration of the item and heard statements by the representatives of Colombia, Poland, Indonesia, the United Kingdom, Kenya, the Netherlands, Uruguay, Sierra Leone, Brazil, China, Finland, Malta, the Khmer Republic, Mexico, Greece, the Upper Volta, Pakistan and Japan (who accepted the amendments to draft resolution A/C.2/L.1268 orally proposed by the United States).

The Committee adopted, by 86 votes to 8, with 3 abstentions, the draft resolution in A/C.2/L.1268, as orally amended.

Explanations of vote after the vote were made by the representatives of Greece, Hungary, Norway, Liberia, Belgium, Canada, the Ukrainian SSR, Jordan, Denmark, Mexico, Iraq, the USSR and Ethiopia.

Fundação C

United Nations Conference on Trade and Development [43]

The Committee continued its consideration of draft resolution A/C.2/L.1248/Rev.1, amendments thereto in A/C.2/L.1275, and the statement of financial implications of the draft resolution, contained in A/C.2/L.1259.

Statements were made by the representatives of Sri Lanka, Norway, Japan, New Zealand, Australia (who proposed amendments to the draft resolution), Canada, India, Greece, France, Sweden, the United States, Brazil, Italy, Denmark, Nigeria, Ghana, Belgium, Honduras and the United Kingdom. The representative of Sri Lanka, on behalf of the sponsors, accepted the oral amendments proposed by Australia.

It was announced that Nepal had joined the sponsors of the draft resolution A/C.2/L.1248/Rev.1.

By 38 votes to 37, with 34 abstentions, the Committee rejected a motion by the United Kingdom, and opposed by the Upper Volta, to suspend the meeting for five minutes.

The Committee then proceeded to a recorded vote, at the request of Brazil, on the draft resolution A/C.2/L.1248/Rev.1 and on the amendments submitted thereto (A/C.2/L.1275) as follows:

It was announced that Burundi had joined the sponsors of draft resolution A/C.2/L.1260/Rev.1; and that Burundi, Cameroon and Nepal had joined the sponsors of draft resolution A/C.2/L.1274.

Operational activities for development [46]

Revised draft resolution A/C.2/L.1262/Rev.1

Statements were made by the representatives of Sweden, the Libyan Arab Republic, the Philippines, Pakistan (who proposed the addition of a new operative paragraph 3 to the revised draft resolution), Cuba, and the United States.

The Committee then, by 27 votes to 24, with 57 abstentions rejected the proposed amendment submitted by Pakistan, and by 102 votes to 1, with 10 abstentions, adopted the revised draft resolution (A/C.2/L.1262/Rev.1).

Statements in explanation of vote after the vote were made by the representatives of Brazil, Colombia, Norway, Nigeria, Honduras, Guatemala, Ethiopia, Egypt, India, Canada, Madagascar, Denmark, Mexico, El Salvador, Iraq, Cuba and Pakistan.

It was announced that Egypt, Ghana, Kenya, the Philippines, the Syrian Arab Republic and Uganda had joined the sponsors of the draft resolution contained in document A/C.2/L.1263, and that Mali Lad joined the sponsors of the draft resolution contained in document A/C.2/L.1272.

THIRD COMMITTEE

1965th meeting

Importance of the universal realization of the right of peoples to self-determination and of the speedy granting of independence to colonial countries and peoples for the effective guarantee and observance of human rights [51]

The Committee concluded its consideration of item 51 and of the draft resolution submitted on it which, in its revised form (A/C.3/L.1973/Rev.1) was sponsored by Afghanistan, Algeria, Cameroon, the Congo, Cuba, Egypt, Ghana, Guinea, Indonesia, Mali, Mauritania, Morocco, Rwanda, Senegal, the Sudan, the United Republic of Tanzania, the Upper Volta and Zambia, and subsequently, by Chad and Togo.

The representatives of Ghana, Greece and the USSR made statements.

The representatives of Sierra Leone, Iraq and Israel explained their votes before the voting.

The representative of Greece suggested the addition of certain words to the last preambular paragraph, which were incorporated in the text by the sponsors.

The Director of the Division of Human Rights made a statement relating to the financial implications of the draft resolution.

The representatives of the Byelorussian SSR and Chad also made statements.

At the request of the representative of Uruguay, supported by Ecuador, the draft resolution was voted on paragraph by paragraph. At the request of the representative of Zambia, operative

paragraphs 2 and 3 were voted on by roll-call. At the request of the representative of Mauritania the draft resolution as a whole was also voted on by roll-call. The results of the voting were as follows:

The representatives of the Byelorussian SSR, the Netherlands, Poland, Czechoslovakia, Yugoslavia and the USSR made statements.

The representative of the United States made a statement in exercise of the right of reply.

Elimination of all forms of religious intolerance [59]

The Committee began consideration of the item and of the draft resolution submitted on it in document A/C.3/L.1980, sponsored by the Netherlands, Sweden and Uruguay, and subsequently by Cyprus.

The Director of the Division of Human Rights, representing the Secretary-General, made an introductory statement.

The representatives of Sweden, India, Portugal, the Byelorussian SSR, the Netherlands, Ecuador and Cyprus made statements.

The representative of the Byelorussian SSR suggested a number of amendments to various paragraphs of the draft resolution.

At the suggestion of the representative of Ecuador, supported by the representative of the Netherlands, the Chairman proposed, and the Committee agreed, to postpone the voting on the draft resolution until a future meeting.

Youth, its education in the respect for human rights and fundamental freedoms, its problems and needs, and its active perticipation in national development and international cooperation [54]:

- (a) Channels of communication with youth and international youth organisations;
- (b) Implementation of the Declaration on the Promotion among Youth of the Ideals of Peace, Mutual respect and Understanding between Peoples.

The Committee began consideration of item 54.

The Assistant Secretary-General for Social and Humanitarian Affairs made an introductory statement relating to sub-item (a).

Burundi became a co-sponsor of the draft resolution contained in document A/C.4/L.1014.

The representative of the Cameroon made a statement.
