GENERAL ASSEMBLY

2081st plenary meeting

Reports of the Fifth Committee on items 71 and 93

The Rapporteur of the Fifth Committee introduced the reports of that Committee (A/8873 and Corr.1 (Chinese and Spanish only) and A/8861).

Financial reports and accounts for the year 1971 and reports of the Board of Auditors: report of the Fifth Committee (A/8873 and Corr.1 (Chinese and Spanish only)) [71]

The Assembly adopted, without objection, the draft resolutions A to F recommended by the Fifth Committee in paragraph 11 of its report (A/8873 and Corr.1 (Chinese and Spanish only)) [resolutions 2912 A to F (XXVII)].

Amendment to rule 160 of the rules of procedure of the General Assembly: report of the Fifth Committee (A/8861) [93]

The Assembly adopted, without objection, the draft resolution recommended by the Fifth Committee in paragraph 5 of its report (A/8861) [resolution 2913 (XXVII)].

Adoption of the agenda of the twenty-seventh regular session and allocation of items: note by the Secretary-General (A/8876) [8]

The Assembly decided to add the following sub-item to agenda item 76:

"(f) United Nations Staff Pension Committee"

and to refer it to the Fifth Committee

Reports of the First Committee on items 28, 29 and 37

The Rapporteur of the First Committee introduced the reports of that Committee (A/8863 and A/8864).

International co-operation in the peaceful uses of outer space; preparation of an international treaty concerning the Moon [28 and 29]:

- (a) Report of the First Committee (A/8863);
- (b) Report of the Fifth Committee (A/8869)

The Assembly adopted unanimously draft resolution I [resolution 2914 (XXVII)] and draft resolution II [resolution 2915 (XXVII)] as recommended by the First Committee in paragraph 12 of its report (A/8863).

Preparation of an international convention on principles governing the use by States of artificial earth satellites for direct television broadcasting [37]:

- (a) Report of the First Committee (A/8864);
- (b) Amendments submitted by Belgium, Iraq, Italy, Mongolia, the Netherlands and Poland (A/L.682/Rev. 1)

The representative of Italy made a statement and introduced the amendments contained in docume. A/L.682/Rev.1.

The Assembly adopted by 91 votes to none, with 7 abstentions, the first amendment contained in document A/L.682/Rev.1.

It then adopted by 95 votes to none, with 6 abstentions, the second amendment contained in document A/L.682/Rev.1.

The representatives of the USSR, the United States and Colombia made statements in explanation of vote.

The Assembly voted on the draft resolutions recommended by the First Committee in paragraph 23 of its report (A/8864) as follows:

The general debate concluded with statements by the representatives of Japan, Pakistan, Ethiopia, Algeria and the United Kingdom.

FIFTH COMMITTEE

Pattern of conferences [75]

The Chairman of the Advisory Committee on Administrative and Budgetary Questions and the Under-Secretary-General for Conference Services made introductory statements.

Statements were made by the representatives of France and Italy.

Report of the United Nations Joint Staff Pension Board [82]

The Chairman announced that the Secretary of the Committee would make copies of a related audit report available to delegations on request. The representative of Colombia indicated his agreement to this arrangement.

By 79 votes to 7, with 3 abstentions, the Committee approved Part I of the draft resolution in Annex V of document A/8709. It then approved, without objection, Part II of the draft resolution. The Committee further agreed to recommend to the General Assembly that it endorse paragraphs 15, 20 and 40 of the report of the Advisory Committee in document A/8860.

The Special Committee decided to refer a number of communications for consideration by the Sub-Committee on Petitions.

Other matters

On the proposal of the representative of Somalia, the Special Committee decided to consider in the future lists of persons in South Africa against whom allegations of maltreatment and torture of prisoners have been made.

Statements were made by the Chairman, the Rapporteur and the representative of Trinidad and Tobago concerning preparations for future special sessions. The Special Committee requested its ad hoc group, under the chairmanship of the permanent representative of Trinidad and Tobago, to continue its work.

The Rapporteur made a statement on recent developments in South Africa. Statements were made by the representatives of Somalia, the Philippines, the Sudan and Ghana.

The Special Committee agreed that the Rapporteur submit a report to the Special Political Committee on some of the matters discussed.

SIGNATURES, RATIFICATIONS, ETC.

On 8 November 1972, the instrument of ratification of the amendment to Article 61 of the Charter of the United Nations, adopted by General Assembly resolution 2847 (XXVI) of 20 December 1971, was received from the Government of Tunisia.
