## NOTIFICATION

The United Nations General Assembly, by its resolution 47/180 of 22 December 1992, decided to convene the United Nations Conference on Human Settlements (Habitat II). The Conference (HABITAT II) will take place in Istanbul, Turkey, from 3-14 June, 1996.

HABITAT II will place urbanization at the top of international and national development agendas. It aims to promote new policies and strategies for urban management and housing development, and to help solve urban environmental problems. It will also highlight the needs and opportunities for investment in infrastructure and services.

The HABITAT II process offers an opportunity for NGOs to enhance the outreach and efficiency of their work by learning from the experiences of other NGOs and CBOs, sharing their expertise, and forging new partnerships with like-minded groups. Perhaps more than ever before, NGOS will have an opportunity to influence the global agenda, given their unique place among actors on the urban stage.

The Preparatory Committee for Habitat II, at its organizational session in New York in March 1993, adopted the modalities for participation in and contribution of NGOs to the Conference and its preparatory process. The Preparatory Committee held two substantive sessions: the first in Geneva from 11-22 April, 1994, and the second in Nairobi from 24 April-5 May, 1995. The third and final session of the Preparatory Committee will take place in New York from 5-16 February, 1996.

Non-governmental organizations in consultative status with the Economic and Social Council (ECOSOC), and those accredited to the Commission on Sustainable Development (CSD), will be accredited for participation at Habitat II and the meetings of its Preparatory Committee if they express their wish to attend. It is required, however, that ECOSOC and CSD-associated NGOs wishing to attend the third session of the Preparatory Committee should confirm that wish in writing before 15 January, 1996, to the Habitat II Secretariat at either of the addresses below, indicating the names of their representatives.

Other NGOs wishing to be accredited to the Habitat II Conference and the third meeting of its Preparatory Committee may apply by completing the attached form and returning it to either of the addresses indicated below. Applications must be recieved at least three weeks in advance of the third meeting of the Preparatory Committee or the Conference, whatever the case may be. An NGO that has been granted accreditation to attend one session of the Preparatory Committee may attend all future sessions, as well as the Conference itself.

Please note that applications for accreditation that do not include the required information and documentation will not be considered.

In the evaluation of the relevance of non-governmental applicants for accreditation to the Conference and its preparatory process, it is agreed that their background and involvement in human settlements issues will determine their relevance.

Accreditation is subject to approval by the Preparatory Committee of the roller COULDAY O FULUIO
