Chile: Marjorie Agosin is the author of two volumes of poetry, has published several articles dealing with contemporary Latin American women writers, and is an assistant professor of Latin American literature at Wellesley College in Massachusetts.

China: Xiao Lu (a pseudonym) was born in China in 1939. She is a professor at a major university.

Cuba: La Silenciada ("The Silenced One") is an artist who actively participated in the 1959 revolution, and "an author whose desire for freedom of expression coincides with that of Rosa Luxemburg -- who argued with Lenin on this matter".

Denmark: Tinne Vammen is a historian and is currently a member of the editorial board of Kvinder.

Ecuador: Carola Borja is a member of the Women's Action Group of the United Nations Development Program and a contributor to an analytical paper for a report on the Status of Women in UNDP/UNFPA.

Egypt: Nawal El Saadawi is a medical doctor, novelist, and non-fiction writer on Arab women's struggle for liberation. In 1972 she lost her post in the Egyptian Ministry of Health, and in 1981 was imprisoned in Cairo because of her writings.

France: Simone de Beauvoir was one of the founders of French existentialism and has published philosophical writings (escays and books) as well as authoring novels, memoirs, and political works. A political activist as well as theorist all her life, she is a founder of numerous French feminist organizations including Choisir, Ligue du droit des femmes, the newspaper Nouvelles Feministes, and the journal Questions Feministes.

Germany (East): Irmtraud Morgner lives in East Berlin and has written four novels. She is published by Aufbau-Verlag in East Germany and by Luchterhand in West Germany.

Germany (West): Dr. Renate Berger is an art historian living in Hamburg. Her doctoral thesis was "Women Artists on Their Way into the Twentieth Century: Art History as Social History".

Ingrid Kolb is a journalist living in Hamburg, working for the magazine Stern. The series she wrote for it, "The Myth of Sexual Liberation", has since appeared as a book.

Marielouise Janssen-Jurreit was editor of and reporter for the German magazine Twen and a correspondent on the war in Vietnam. Her book Sexism was published in 1976 (US edition: Sexism, New York: Farrar, Strauss & Giroux, 1981).

Ghana: Ama Ata Aidoo's publications include The Dilemma of a Ghost, a play, No Sweetness Here, a collection of short stories, Our Sister Killjoy or Reflection From a Blackeyed Squint, fiction in four episodes (Harlow: Longman). She has also published other short stories, poems, reviews, and critical essays in many anthologies and journals.

Guatemala: Stella Quan has lived in Mexico since 1963, when she had to emigrate from Guatemala. She is an anthropologist. In January of 1980 she, and other Latin American women, founded AIMUR (International Agrupation of Women Against Repression in Guatemala).

She took part in a 1973 campaign organized by women to defend reproductive freedom in Hungary; for this activity she was excluded "forever from all universities of Hungary" and prevented from working in her profession. She is now a free-lance journalist and translator based in Paris.

Indonesia: <u>Titi Sumbung</u> has practiced law, worked as a government civil servant, was involved in drafting the Marriage Act, was a member of the Advisory Board to the National Family Planning Coordinating Board, and was on the Research Team on the Status of Women and Family Planning. Since 1967 she has been involved in the Indonesian women's movement.

Iran: Manhaz Afkhami is the founder of the Association of Iranian University Women and served as secretary-general of the Women's Organization of Iran from 1970 until the revolution of 1979. She was Minister of State for Women's Affairs from 1976 to 1978.

Ireland (s): Nell McCafferty helped found the Irishwomen's Liberation Movement. She has published two books, The Armagh Women and The Eyes of the Law.

Italy: Paola Zaccaria was born in the South of Italy (Monopoli). While active in a small feminist group in her town, she graduated in foreign languages at the University of Bari, where she now teaches English literature and language.

Japan: Keiko Higuchi is author of a number of books, including Jobs Fit For Women, Bringing Up Girls, Women, You Have Only One Life, Toward Tomorrow's Women, and Dear Old Age: Aged Characters in Literary Works.

Korea (South): Soon Chan Park was born in 1898. In 1948 she founded the Korean National Women's Association and was elected its first president. She founded the first Korean women's newspaper and became its editor, and was elected to the National Assembly and was re-elected for two terms. On Monday, January 10, 1983, at age eighty-four, Soon Chan Park died in Seoul.

<u>Kuwait:</u> <u>Noura Al-Falah</u> teaches sociology at Kuwait University, focusing on the problems facing women, the distribution of the national income and the Kuwait social structure.

<u>Lebanon: Rose Ghurayyib</u> has published books on literary criticism and literary studies about contemporary Arab women poets. She currently edits <u>Al-Raida</u>, the newsletter of the Institute for Women's Studies in the Arab World.

Libya: Farida Allaghi was vice-chairperson in 1977 at the UN Committee on the Status of Women, and was the committee representative to the meetings of the Subcommittee on Human Rights in Geneva in 1978. A sociologist, she is also an active member of the preparatory committee for the Foundation of the Association of Arab Women Social Scientists.

Morocco: Fatima Mernissi studied political science and then sociology at Mohammad V University, where she taught from 1974 to 1980. She is currently a Researcher at the Centre Universitaire de Recherche Scientifique in Rabat. Her publications include a feminist classic -- Beyond the Veil.
